**Dare County Board of Commissioners Postpone Property Revaluation**

The Dare County Board of Commissioners passed a resolution on April 19, 2010 that postpones the revaluation until January 1, 2013.

Originally the County advanced its schedule for revaluation to January 1, 2010 and established a five year cycle for revaluation. The County then postponed its revaluation to January 1, 2011 by resolution on September 21, 2009. The schedule has again been postponed to January 1, 2013 and the County will remain on a five year cycle for revaluation.
